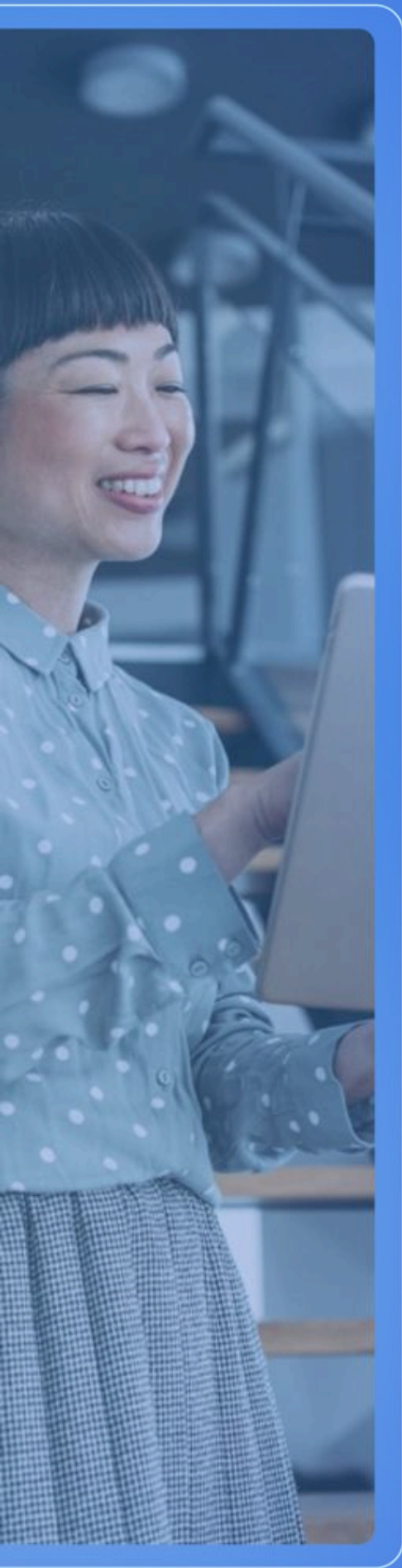

These fields capture critical NDIS data points directly in Wiise, including:

- NDIS participant numbers
- Plan manager details
- Support item reference numbers
- Funding types
- Service booking IDs
- Price guide codes and rates
- Claim category tagging

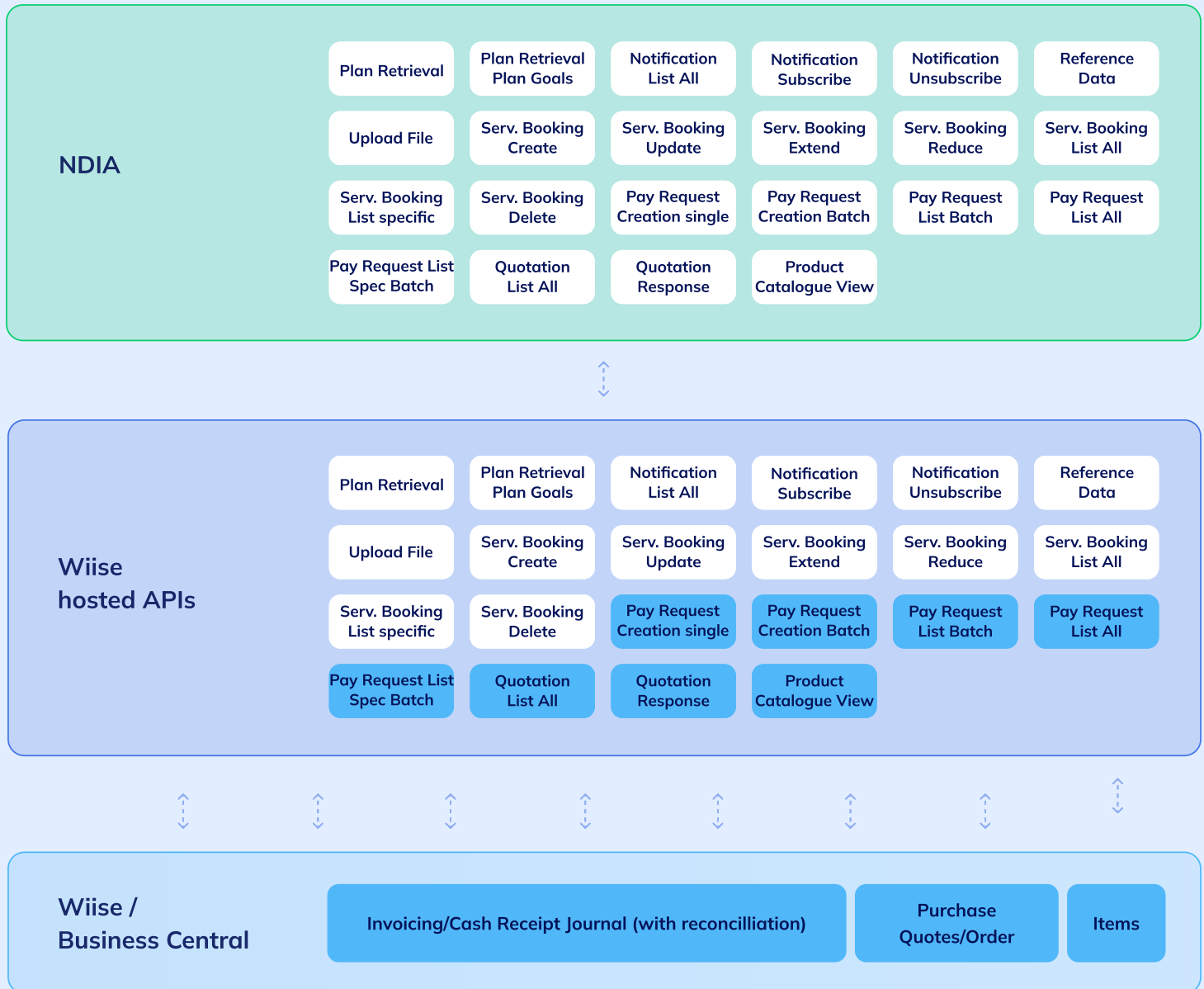
System Integration Overview



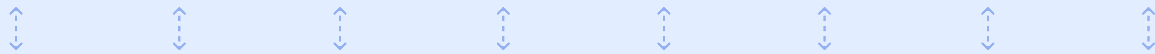
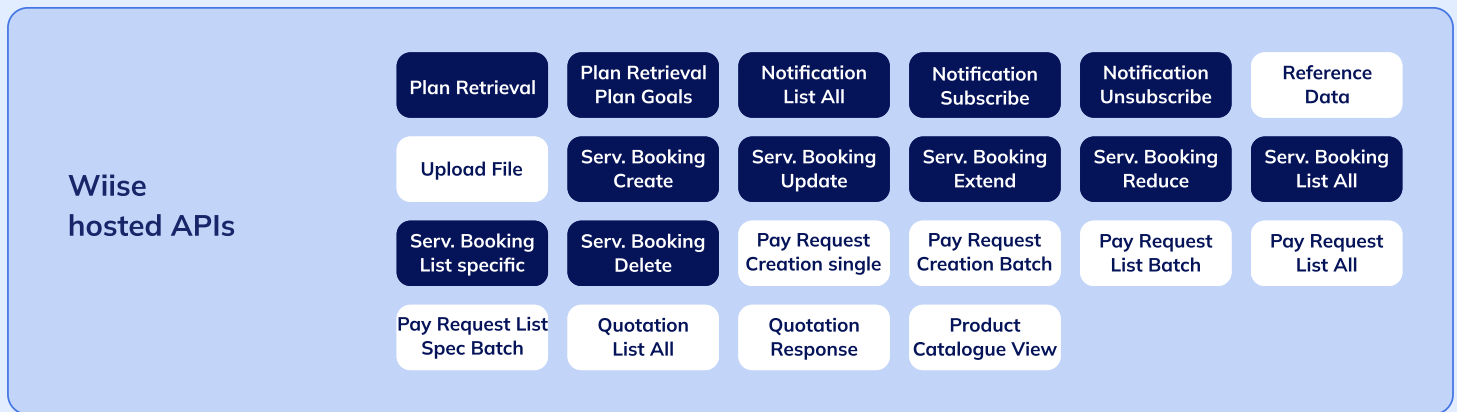
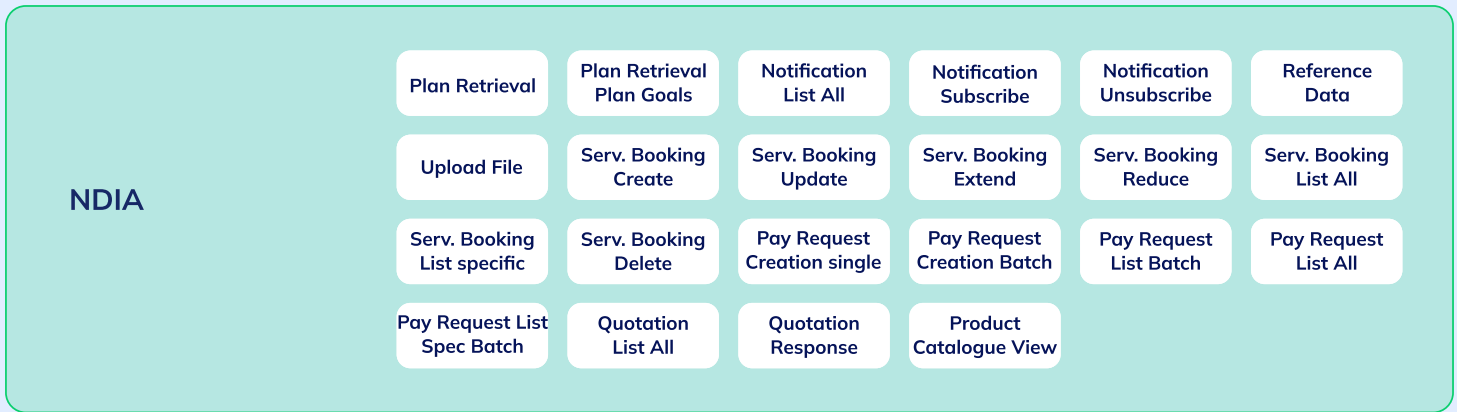
API Integration between systems

Care Management NDIA data fields





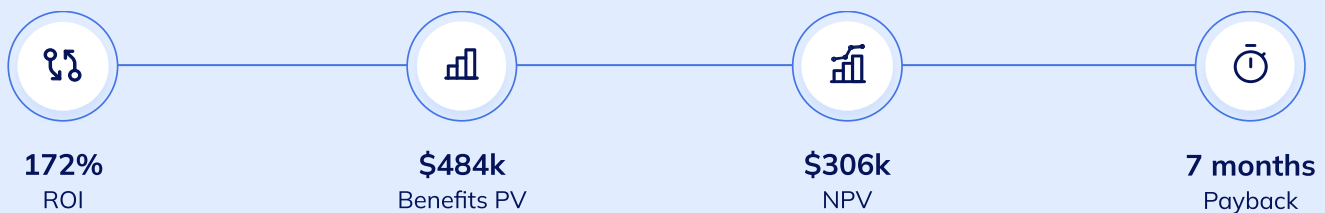
